

# MEMORANDUM OF UNDERSTANDING (Mou) Your Partner for Prosperity

# 1. OBJECTIVES OF THE MOU

- g. There is no financial commitment on the part of both <a href="GLAU">GLAU</a> and <a href="Shriram Life">Shriram Life</a> Insurance Company Limited (DSO Channel), the <a href="GLAU">GLAU</a> and <a href="Shriram Life">Shriram Life</a> Insurance Company Limited (DSO Channel) to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt seperately.

Each of the above modes of interaction will be initiated by entering into a separate agreement between the two parties.

## 3. CONFIDENTIALITY

Each Party undertakes that it will not at any time use, divulge or communicate to any person, except to its professional representatives or advisers or as may be required by law or any legal or regulatory authority, any Confidential Information concerning the business or affairs of the other Party which may have come to its knowledge as a result of entering into this Memorandum and each of the Parties shall use its reasonable endeavors to prevent the publication or disclosure of any Confidential Information concerning such matters. For the avoidance of doubt, this paragraph is legally binding and survives termination of this Memorandum. For the purposes of this Memorandum, "Confidential Information" shall mean All information (of whatever nature and however recorded or preserved) disclosed by one Party to the other, which: (a) is marked as or has been otherwise indicated to be confidential; or (b) derives value to a Party from being confidential; or (c) would be regarded as confidential by a reasonable business person; except to the extent that such information is already in the public domain at the time of disclosure or enters the public domain otherwise than by a breach of any obligation of confidentiality.

## 4. INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### 5. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular training or research agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

## 6. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 3 years after the effective date specified in the opening paragraph. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Training, Research or similar Agreement, Confidentiality clause as referenced in clause 3 above, or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

### 7. ASSIGNMENT

None of the parties shall assign any of its rights under this Agreement without the prior written consent of the other parties, such consent not to be unreasonably withheld.

### 8. AMENDMENTS

This Agreement can only be amended, varied, released or discharged by written agreement of the parties.

## 9. SEVERABILITY

If any provision in this Agreement is void or unenforceable that provision will be severed and the rest of this Agreement will remain in full force and effect.

### 10. RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the Party, without the prior
