

## Memorandum of Understanding Between

## National Council for Cement and Building Materials, Ballabhgarh, Haryana and GLA University, Mathura, UP



12-B Status from UGO

National Council for Cement and Building Materials, Ballabgarh (hereinafter referred to as NCCBM) is the premier body under the administrative control of Ministry of Commerce and Industry, Government of India, for technology development, transfer, continuing education, and industrial services for cement and construction industries. Geographically, NCCBM has its corporate centre and main laboratories located at Ballabgarh, another well-established regional centre at Hyderabad, and project offices at Ahmedabad and Bhubaneshwar.

The GLA University, Mathura (hereinafter referred to as GLAU) established under U.P. State Legislative Act of 2009 (UP Act 21 of 2010) and ranked among the top Universities of Uttar Pradesh and India and has been accredited by the National Assessment and Accreditation Council (NAAC) with 'A' Grade and 12B status from UGC and recognized by University Grants Commission (UGC) under section 12B of UGC Act of 1956, having its campus at NH-2, Mathura-Delhi Road P.O. Chaumuhan, Mathura, Uttar Pradesh 281406.

This Memorandum of Understanding (MoU) between NCCBM and GLAU, is signed with the objective of fostering collaboration between the two institutions to promote academic and research interactions, and to provide for the following:

- NCCBM would endeavor to facilitate the internship training to GLAU students of Engineering & Science (Chemistry, Electrical, Mechanical, Chemical and Civil Engineering) inline of NCCBM's Internship Policy.
- NCCBM and GLAU will facilitate sharing of laboratory facilities, library facilities, and materials including software and other components developed in-house for research purpose only, as per mutually agreed terms and conditions.
- NCCBM and GLAU will exchange ideas, materials and manpower with a view to enhancing mutually beneficial R&D activities, which would have a bearing on addressing national issues and problems.
- 4. NCCBM and GLAU will explore the possibility of jointly conducting seminars / workshops / conferences at national and international levels, in areas of mutual interest.
- GLAU shall recognize NCCBM as an external research center and scientist & engineers of NCCBM working on R&D Projects may be registered for PhD Program at GLAU under the joint supervision of a Ph.D guide from NCCBM and GLAU. Principal guide may either be from NCCBM or GLAU.

NCCBM and GLAU will put in place adequate and reasonable measures to keep confidential information secure to prevent any unauthorized use. There will be no restriction on the publication of the results of collaborative research, except where such outcome has implications for the security of the State. NCCBM and GLAU will be free to carry out follow-up research independently. Rights regarding publications, patents, royalty, ownership of software/design/products etc., developed under the scope of this MoU, shall be decided

by mutual discussion. Separate policy documents in this regard will be framed, consistent with the rules and regulations of NCCBM and GLAU.

NCCBM and GLAU will jointly develop and devise implementation strategies and time-bound action plans to effectively meet the desired objectives and goals. Financial arrangements for each specific activity will be decided on a case-to-case basis and brought on record in each case after due approval from heads of NCCBM and GLAU.

A joint Coordination Committee consisting of a nominee of Director General, NCCBM as Chairman, and a nominee of Director, GLAU as Co-Chairman, and two nominees each from NCCBM and GLAU, would coordinate and monitor the academic and research programs and all related operational matters within the framework of the academic regulations of GLAU and the objectives of NCCBM.

This MoU is effective from the date of signing and will remain so for a period of five years. This MoU may be extended for another period on mutually agreeable terms and conditions.

Either NCCBM or GLAU shall be at liberty to terminate this MoU by providing a prior written notice of six (6) months. However, in case of such early termination, both NCCBM and GLAU will have to ensure that none of the ongoing educational, training, or research programmes will be affected.
