hereinafter referred as SECOND PARTY.

First party and second party are hereinafter jointly referred to as "Parties" and individually as "Party" in this MoU document.

By the grace of God Almighty and based on their desire to work together in the Implementation of Tri Dharma of Higher Education and Human Resource Development, the Parties jointly agree to a MoU with the following conditions:

Article 1 PURPOSE AND OBJECTIVES

- (1) The purpose of this MoU is to carry out cooperation in an integrated, synergistic and sustainable manner;
- (2) The objectives of this MoU is to improve and develop the Implementation of the Tri Dharma of Higher Education and Development of Human Resources, and to improve the quality of resources and institutions in accordance with the functions and authorities of the Parties.

Article 2 SCOPE

The scope of this MoU includes:

- (1) Organizing Education and Teaching, Research, and Community Service;
- (2) Organizing Scientific Activities, Seminars and Workshops;
- (3) Improvement and Development of Human Resources Competencies; and
- (4) Other activities agreed by the Parties

Article 3 **IMPLEMENTATION**

- (1) The implementation of this MoU is further regulated, performed by the representative assigned to each of the Party and is the sole and exclusive entity of this Agreement;
- (2) Things that have not been listed in this MoU will be set forth in detail in the Memorandum of Agreement (MoA) which will be prepared later by the Parties.
- (3) The Parties agree to conduct monitoring and evaluation once every year.

Article 4 **FINANCING**

All costs incurred in connection with all activities to be performed under this MoU will be set forth in the form of a MoA which is an integral part of this MoU.

Article 5 **DURATION AND TERMINATION**

- (1) This MoU shall enter into force and effect for a period of 5 (five) years from the date of its signature and can be extended based on the agreement of the Parties;
- (2) Any party may extend this MoU by providing no later than six (6) months prior written notice to the other Parties;
- (3) In the event that the provisions referred to in paragraph (2) are not fulfilled, this MoU is automatically terminated according to the time period.

Article 6 DISPUTE RESOLUTION

Article 7 **MISCELLANEOUS**

Things that have not been regulated or complements in this MoU will be further regulated in the additional agreement (addendum), which is an integral part of this MoU.

Article 8 **CLOSING PROVISION**

This MoU was made and signed in Singaraja on the day, date, month and year as stated on the beginning of this document, in duplicate 2 (two) each has the same sound, is sufficiently stamped and has the same legal force to be used properly.
