NOTICE

Kindly refer to earlier Notice No. COE/04/17-18 dated 03.11.2017 which is reproduced as under:

“Carry Over Examinations are being arranged in January-February 2018 for:

- (a) Non-graduating students of passing out batches of 2016-17 and previous years.*
- (b) Students of final year of their studies, and*
- (c) Students promoted to next year of higher studies and studying at present.*


The limit of carry over papers permissible for this examination for students of **category (c)** shall be a maximum of **Two Subjects** and that too of **Odd Semesters / Trimesters**. Carry Over Examinations will also be arranged for discontinued papers / subjects on certification from Head of the Department.

Form No. 2 will be used for registration of carry over subjects for this examination and it will be available from window counter of Room No. 122 of Academic Block-I for all eligible students from **November 06** to up to **January 10, 2018** only. The duly completed Form No. 2 **with exact amount of fee** will be accepted for **registration from November 06 to up to January 10, 2018** in Room No. 118 in person in Academic Block-I only. **Thereafter, no form will be accepted for registration.**

The carry over examinations shall be of three hours' duration with question papers of 80 marks from entire syllabus as per the format attached and displayed on Notice Board of Examination Cell.

The plausible dates of examinations shall be **January 20 & 27, February 03 & 24, and March 10 & 17, 2018**. The examination schedule will be made available in *examination menu on website of the University by January 17, 2018*. It shall be the responsibility of the student appearing in this carry over examination to see this schedule with changes there in, if any, until a day before the start of CO Examination and appear in examination with self-study on scheduled date and time. No separate intimation will be sent to any student regarding the examination schedule”.

In the context, it is further clarified that students of II & higher years of all programmes can also write Carry Over Examinations of I-year subjects by filling forms by deadlines as above and appear in CO Examinations to be held in Even Semester 2017-18.
