Kindly refer to Notice No. COE/01/17-18 dated 02.08.2017 with following text:

"Carry Over Examinations are being arranged for:

- (a) Students of passing out batches of 2016-17 and previous years.
- (b) Students promoted to next year of higher studies and studying at present.

The limit of carry over papers permissible for this examination for students promoted to next year of higher studies (Category-b) shall be a maximum of **Two Subjects** and that too of **Even Semesters** / **Trimesters**. Carry Over Examinations will also be arranged for discontinued papers / subjects on certification from Head of the Department.

Form No. 2 will be used for registration of carry over subjects for this examination and it will be available from window counter of Room No. 122 of Academic Block-I for all eligible students from August 08 to up to August 19, 2017 only. The duly completed Form No. 2 will be accepted for registration from August 08 to up to August 21, 2017 in Room No. 118 in person in Academic Block-I only. Thereafter, no form will be accepted for registration.

The carry over examinations shall be of three hours' duration with question papers of 80 marks from entire syllabus as per the format attached and displayed on Notice Board of Examination Cell.

The plausible dates of examinations shall be September 02 / September 09 / September 16 & September 23, 2017. The examination schedule will be made available in *examination menu on website of the University by August 24, 2017*. It shall be the responsibility of the student appearing in this carry over examination to see this schedule and appear in examination with self-study on scheduled date and time. No separate intimation will be sent to any student regarding the examination schedule".

I have come to know that several students have not filled the forms but are willing to write Carry Over Examinations of Back Papers of Even Semesters and students of pass out batches of Odd & Even Semesters. In interest of these students, the last date is extended to August 28, 2017.
