Regarding Diploma course (17-1007/2013-PCI), it was decided to i) grant approval for 2014-2015 academic session for 60 admissions for the conduct of 1st year D.Pharm course. ii) allow 60 admissions for 2014-2015 academic session subject to submission of affiliation fee per annum to the PCI within the stipulated time period. It was further decided to instruct the institution— i) that every year it has to apply to PCI in the SIF for the conduct of early inspection for year-wise approval or rejection of approval on the basis of which the institution can make further admission/no admission. When the students are in the final year D.Pharm an inspection will be conducted by PCI for consideration approval of D.Pharm course u/s 12 of the Pharmacy Act for the purpose of registration as pharmacist. It is the responsibility of the institution to apply in the prescribed SIF to PCI within the prescribed dates every year alongwith complete documents. ii) to comply with the requirements of Education Regulations, 1991 particularly regarding appointment of teaching staff and equipments. Regarding Degree course (32-614/2010-PCI), it was further decided to insist for appointment of teaching staff.
